## Foreword

The year 2003, about which I present to you this Report, was not just another ordinary year in the life of the Munich Intellectual Property Law Center; it was, and will always be remembered as, the year of the Center's birth. After years of negotiations, the Center was inaugurated at a Founding Ceremony on March 17, 2003. With the generous cooperation of the Bavarian Ministry for Science, Research and the Arts, the four partners were able to gain formal approval of the Masters Program in Intellectual Property in record time. At the same time, we were busy recruiting faculty from all over the world, finalizing the administrative details of the program, and beginning to advertise for students. By October, we were able to attract students from eight countries located on five continents. As I write this Foreword, those students, comprising the very first class of the MIPLC IP LL.M. Program, are just about to pass their last exams and submit their Master's Theses.

As I and the other members of the MIPLC Managing Board look back over the past year, the first thing we realize is how many people we have to thank for their critical contributions to this new venture. From the very beginning we have been indebted to the leaders of the four MIPLC partners for their firm commitment to this unique cooperation, and for their willingness and ability to handle complicated issues skillfully and flexibly. Without that skill and flexibility, and without the friendly and helpful approach of the Bavarian Ministry for Science, Research and the Arts, we could never have started the LL.M. program in the fall of 2003, a mere six months after the Center was created.

The LL.M. Program itself is the work of all of our dedicated faculty members – since there are over fifty of them, I unfortunately cannot thank each of them by name in this Foreword – as well as Ms. Margit Hinkel and Ms. Sabine Müller, the MIPLC Administrative Directors, and the tutors who assisted the students during their studies. Without their energy, discipline, and devotion, the program could not have succeeded. We would like to single out for special commendation Dr. Ralph Nack, who is leaving his position as the MIPLC Program Coordinator after having put in a truly extraordinary effort to guide the LL.M. Program through its first year. We extend our welcome to Wolrad Prinz zu Waldeck und Pyrmont, who will succeed Dr. Nack as Program Coordinator after having been successfully involved with the program as a tutor this past year.

The LL.M. Program was always conceived of as including a practical, real-world component, and we are grateful to the many law firms, organizations and government agencies which made that possible by hosting students as interns. We are also extremely appreciative of the generosity of our first benefactors: to Professor Martin Adelman for endowing the Adelman Enrichment Fund; to Mr. and Mrs. Siegfried and Gertrud Oehm for creating the Oehm Prize; and to the firms of Siemens and Schering for funding the Siemens-Schering scholarship.

During the past year, we have also been able to appoint the members of all of the MIPLC institutional bodies required under the regulations of the Max Planck Society, including the Scientific Advisory Board, the Board of Trustees, and the Scientific Advisory Board (Fachbeirat). We are greatly indebted to all who are willing to serve on these boards, which are of utmost importance for the success of our work.

Last, but certainly not least, we want to thank each and every one of the students in the LL.M. Class of 2004, our very first class, both for their adventurousness in enrolling in an untested program, and for their patience as everything was done for the first time.

We look forward to the coming year with eagerness and optimism. We will be welcoming a larger class of students to the LL.M. program this October, and we will begin pursuing the research activities that form another important part of our mandate. Thus, though 2003 will always be a memorable year for us, we are confident that we will have new and exciting achievements to report each year for many years to come.

# 1. Founding the MIPLC

## Foundation

After three years of preparatory work, in 2003 the Munich Intellectual Property Law Center became reality. The formal “date of birth” can be considered March 10<sup>th</sup>, when the Cooperation Agreement, signed by the four partners – The Max Planck Society (MPG; represented by the Max Planck Institute for Intellectual Property, Competition and Tax Law, MPI), the Technische Universität München (TUM), the University of Augsburg (UA), and the George Washington University (GWU) – entered into force.

## Aims & Tasks

As stated in the Preamble of the Cooperation Agreement, it is

*“the shared wish of the four cooperating partners to strengthen the systematic analysis of intellectual property law and related areas by contributing to the development of the next generation of capable researchers.”*

In order to achieve this goal, the MIPLC, with the contributions of the four partners, will pursue research and education in the areas of intellectual property and competition law. This includes the following projects:

1. The development and administration of an English-language, two-semester **LL.M. program** in the area of intellectual property and competition law, directed to international graduates in law, economics, engineering, natural sciences, and business administration.
2. Preparation and support of **research papers**, particularly those which seek to develop innovative practical recommendations based on the results of research undertaken by the MPI, the UA, the TUM and the GWU. For this purpose, a separate research unit is to be established at the Max Planck Institute.
3. The preparation and staging of **scientific conferences and guest lectures** that are thematically consistent with the interests of the contracting parties in the areas of intellectual property and competition law.
4. Selection, support and coordination of applications for **grants to underwrite MIPLC projects**, especially grants from the European Union research programs.

## Legal & Administrative Structure

The MIPLC is an unincorporated cooperative venture with two **governing bodies**:

The **Managing Board** formulates general policy for and manages the affairs of the MIPLC. It is composed of one director of

the Max Planck Institute, and one professor of the TUM, the UA, and the GWU, respectively. During the constitutive meeting on March 14<sup>th</sup>, 2003, the following members were elected:

The **Scientific Advisory Board** advises the Managing Board on the MIPLC’s research program and on the development of the LL.M. program, as well as on financial issues. It is composed of one representative each from the MPI, the UA, the TUM and the GWU, and of three external members who demonstrate recognized expertise in the research areas of the MIPLC. ## 2. Presenting the MIPLC to the Public

### Founding Ceremony

To commemorate the signing of the Cooperation Agreement, a founding ceremony was held on March 17<sup>th</sup>, 2003, at the Max Planck Institute for Intellectual Property, Competition and Tax Law in Munich.

About 160 persons from the IP area, industry, politics, and media, both from Germany and abroad, came to Munich to celebrate this memorable event. Among the guests were (in alphabetical order)

Furthermore, representatives of IP-related organizations and the bar from Switzerland, Slovenia, Poland, and even the USA and Japan were welcomed among the guests.

The ceremony included speeches by representatives of each of the partners: Professor Peter Gruss, President, and Dr. Barbara Bludau, Secretary General of the Max Planck Society; Professor Joseph Straus, Managing Director of the Max Planck Institute for Intellectual Property; Professor Wolfgang A. Herrmann, President of the Technische Universität München; Professor Wilfried Bottke, Rector of the University of Augsburg; and Professor Michael K. Young, Dean of the George Washington University Law School. All of these speakers highlighted the motivations of their institutions to join the project, and the specific contributions those institutions could offer. On behalf of the Bavarian Government, Minister Dr. Werner Schnappauf stressed the growing importance of intellectual

property rights for research, development and protection of new technologies and thus for commercial success and international competitiveness, and as a consequence the timeliness of the MIPLC's new LL.M. Program.

The official ceremony was followed by a reception which included toasts to the success of the ambitious project.

### PR and Marketing

#### Press and other Media

The founding ceremony was not just a celebration, but also the first effort to present the MIPLC to the world.

A week before the ceremony, press releases introducing the MIPLC and its LL.M. Program were published by the Max Planck Society and the other partners, leading to a number of requests from journalists for further information and for interviews. As a result, several reports about the Center were published by regional and national print media and radio stations.

In addition, the MIPLC itself published various articles about the foundation and the aims of the Center in law journals such as GRUR Int. and in journals addressing German law graduates (JuS, JA, ZfR, JUSTUF, Hemmer Life&Law). Moreover, the Program was advertised in The Economist. All in all these efforts seemingly were successful since a number of applicants referred to them.

Furthermore, thanks to the dedication of Dr. Heinz Goddar, a member of the MIPLC faculty, the international Newsletter of the Licensing Executives Society (LES) briefly introduced the MIPLC to its readers. Also on his initiative, an advertisement was published in the Japanese AIPPI Journal.

### MIPLC Website and Internet

The MIPLC website ([www.miplc.de](http://www.miplc.de)) was established at the end of 2002, and was amended and updated throughout 2003. Special thanks are due to The George Washington University Law School for its support of the website. Links to the MIPLC website were also placed on the partners' websites.

In order to regularly inform those interested in the MIPLC and its development, the MIPLC News Service was established. A subscription form on the website automatically adds the subscriber's e-mail address to a distribution list. From time to time MIPLC sends an e-mail to that list reporting the latest developments. In April, after the application form and instructions had been added to the website, the first MIPLC Newsletter was sent out to more than 300 persons who had subscribed to this service during the first month the subscription form was available.

In addition, the LL.M. Program is listed in the index of international courses of study on the websites of organizations like the DAAD (German Academic Exchange Service), the "Hochschulrektorenkonferenz" (Association of Universities and Other Higher Education Institutions in Germany), and on "ilm-guide.com." On the latter website an additional advertisement

for the MIPLC has been placed on the homepage as well as on the pages for Europe and the US.

### Flyer, Poster, Brochure

As a means for large-scale worldwide promotion of the MIPLC and its LL.M. Program a flyer and a poster were designed and printed (an initial print run of 7,000 flyers and 1,500 posters) and distributed to:

- German, European, US, and South African Universities
- ATRIP (International Association for the Advancement of Teaching and Research in Intellectual Property), all members
- AIPPI (International Association for the Protection of Intellectual Property), selected members
- Selected international companies
- International conferences and seminars (by MIPLC faculty members)
- The German Federal Patent Court
- The European Patent Office
- The Japanese Patent Office
- Attendants of the Founding Ceremony
- MIPLC faculty members

Work on a 24-page image brochure was started in December 2003 and completed in February 2004.

### Gate Germany

MIPLC was also able to begin using the services of Gate Germany to market itself. Gate Germany is a consortium for international higher education marketing founded by the German Academic Exchange Service (DAAD) and the Association of Universities and Other Higher Education Institutions (Hochschulrektorenkonferenz). Its goal is to promote Germany in the international market for education. Gate Germany supports its members, including the University of Augsburg and the Technische Universität München, with professional marketing services. As a result of Gate Germany's support, 52 information centers worldwide provide information about the MIPLC and the LL.M. IP program.

### International Advanced Education Fairs

Through the German Institute for Science and Technology in Singapore (founded by the Technische Universität München), the MIPLC has been represented in a number of higher education fairs around the world; the Institute has agreed to distribute the MIPLC's promotional material and to provide interested candidates with the appropriate information.

## 3. Housing the MIPLC

### Marshallstraße 8 – the MIPLC's New Home

In March 2003, a week before the Founding Ceremony, the MIPLC moved into its new premises at Marshallstraße 8. The new space on the fourth floor of that building provided the necessary facilities for the start of the Program in October: the staff offices, a meeting and seminar room, offices for visiting faculty and guests, the MIPLC library, and, importantly, offices for the students.

Since it is the MIPLC's declared aim to offer "the best education and research in Intellectual Property," optimal working conditions are considered very important. To this end, each student is provided with his or her own workplace in an office shared with one to three other students. Student office resources include not only a desk and shelving, but high-speed internet access, desktop access to a number of legal databases, and access to a common kitchen and lounge.

### Lecture Room

For class sessions, an MIPLC classroom has been established in the main building of the Max Planck Institute, equipped with state-of-the-art conference facilities, including a laptop and projector for presentations as well as internet access for students.

To further improve the studying and teaching conditions, the classroom and the adjacent conference room have both been provided with air conditioning and equipped with videoconferencing facilities (a project completed in spring 2004).

### IT Equipment, Research Tools, Databases

While students are generally required to bring their own laptops, those who are not in a position to do so are provided with desktop computers from the limited MIPLC pool.

All students are also provided with access to the most modern research tools, such as the Lexis/Nexis and Westlaw databases.

MIPLC also recently purchased sophisticated database software to manage efficiently the large amount of data associated with the Center's operations, such as student applications and academic records, correspondence with faculty, public relations, and so on.

### The MIPLC Library

Although students have access to the library of the Max Planck Institute, which is the world's most complete intellectual property library, an additional MIPLC library was established with the aim of providing students ready access to the best possible tools for study. The library is stocked with a large selection of books on all areas and topics taught during the one-year course. Since the library is housed on the student office floor and is exclusively accessible to MIPLC participants, it provides students with immediate access to the most important literature in the areas of intellectual property and competition law.

In 2003, while the technical equipment for the automated check-out terminal was not yet ready, the MIPLC books were temporarily housed in the Tax Law Library of the MPI, two floors above the MIPLC offices. Thanks are due to Mr. Peter Weber, the head of the Max Planck Library, for offering these temporary accommodations, and to Ms. Petra Golombek, librarian in the Tax Law Library, for so kindly taking care of both the books and the students.

## 4. The MIPLC Projects

The following paragraphs present the activities and results of specific MIPLC projects.

### 4.1 The IP LL.M. Program

With the Cooperation Agreement in place, the simple but ambitious aim of 2003 was to give the Program a good start in October – a considerable challenge since there were only seven months to establish a curriculum and schedule, assemble a faculty, and admit a first class of students.

#### Study and Examination Regulations

The Study and Examination Regulations, which set detailed rules for the LL.M. Program, were approved by the Bavarian State Ministry of Science, Research and the Arts on May 15<sup>th</sup>, 2003.

The central features of the LL.M. Program are the following. The Program offers two semesters of intensive full-time study, including a four-week internship and a final Master's Thesis. English is the sole language of instruction. Students are admitted for the winter semester only. With faculty members coming from all over the world, the classes are to a large extent scheduled in intensive blocks. The teaching methods emphasize problem- and case-oriented learning in small groups. To successful participants, the University of Augsburg awards the degree of Master of Laws in Intellectual Property (LL.M. IP).

Two governing bodies are charged with implementing the Regulations: The **Admissions Committee** decides on the applicants' admissions, and the **Study and Examination Board** is responsible for the organization of the courses and the examinations. These bodies currently have identical members:

#### Curriculum

The classes offered by the Program not only cover all areas of European and international intellectual property, competition and media law, but also include topics from important neighboring fields, such as economics and business administration. The courses are divided into three groups:

1. **Introductory Courses**, which address fundamental topics such as the principles of the Civil Law and the Common Law systems and legal research and writing;
2. **Basic Courses**, which are obligatory and cover the core IP areas as well as important topics such as arbitration, licensing, European law, and competition law.
3. **Specialized Courses**, which are electives that allow students to develop advanced knowledge and skills in areas of particular interest.

The complete list of courses offered in the Academic Year 2003/04, including brief descriptions of their contents, is available as Appendix 1.

The class schedule of the Academic Year 2003/04 is included as Appendix 2.

#### Faculty

Apart from the members of the partner institutions who are teaching at the MIPLC, a considerable number of prominent international leaders from academia and practice have joined the faculty. Since 13 faculty members come from the United States, the Program is able to cover comprehensively the Anglo-American common law tradition as well as the European civil law tradition. For this purpose, a number of courses are co-taught by two (and in a few cases even three) faculty members, so that after having attended one of these classes, the students are familiar with the legal background in both traditions.

In order to ensure that all classes are of the highest quality, and to provide feedback to faculty members, students evaluate each faculty member at the end of each class. The evaluation form is included as Appendix 3.

The complete list of the current faculty members is available as Appendix 4.

#### Tutors

In addition to the regular courses, the Program offers special tutorial sessions to the students. The tutors are highly qualified young members of the bar or members of the Max Planck Institute. The tutorials are one of the unique and innovative features of the LL.M. Program and a core element of the effort to provide education of unsurpassed quality.

The tutors have two functions:

First, they are the main contact persons for the students in academic life affairs, and also provide practical advice, particularly to students who have relocated to Munich and are living in Germany for the first time. Whereas many of the professors only stay for a brief period in Munich, the tutors are permanently on site.

Secondly, the tutors are the link between the professor and the students. Therefore, the faculty members are required to instruct the tutors on what to discuss with the students, and they may also give special recommendations with regard to specific students. If a tutor realizes that there are substantial learning deficits or questions that the tutor does not feel competent to answer, the tutor will inform the professor. Tutors are encouraged to collaborate and to pool their academic competence.

There is one tutor session (60 minutes) per student per week and there should be at least one meeting between each professor and the tutors.

The list of tutors supporting the students in the Academic Year 2003/04 is included as Appendix 5.

### Applicants & Students

The first requests about the LL.M. Program arrived in January 2002, long before the Center was actually founded. As expected, the number of requests significantly increased after the Founding Ceremony, and they came from virtually all over the world.

The Center received its first application – from Thailand – on May 2<sup>nd</sup>, 2003. By the time the Program began, candidates from 12 countries had applied: Brazil, Canada, China, Germany, Ghana, Italy, Pakistan, Poland, South Africa, Thailand, the United Kingdom, and the United States. 22 of them were admitted, and in the end 16 enrolled as the first MIPLC IP LL.M. class. The students comprising this class come from five continents and eight countries, including Brazil, Canada, China, Germany, Ghana, South Africa, the United Kingdom, and the United States.

These sixteen students were enrolled for the master's level course "Intellectual Property and Competition Law" at the University of Augsburg. In addition, the students were also registered with the Technische Universität München. An electronic transfer of information between these two universities meant that the students did not need to register separately with the Technische Universität München. Both the student services fee and the cost of a semester's public transport use (63 € together), which are normally collected by each university, had to be paid only once. For the next academic year the total fee has been increased to 120 €, as an extra administration fee will be charged.

The students received a student ID card from both universities, and were therefore able to benefit from student discounts in both Augsburg and Munich.

### Scholarships

In this first year of the Program a substantial number of students were supported by scholarships. The Center plans to continue the practice of offering scholarships at a variety of levels to many applicants, because it is important to have a truly global student body, and many students from developing countries cannot afford to pay full tuition. At the same time, the Center is working to increase the number of students who can afford to pay full tuition, as this is crucial to the Center's long-term financial health.

The Max Planck Society has funded scholarships which support five of the students throughout the academic year.

Another scholarship covering half of the tuition fee for one student was sponsored in equal shares by Siemens AG and Schering AG, to whom we wish to express our sincere thanks.

### Social Events

The beginning of the academic year for the first class of MIPLC students was celebrated on November 6<sup>th</sup>, 2003. The students, the resident faculty, the tutors, the members of the Boards, and the staff were invited to a Welcome Party with Bavarian buffet and piano music.

In December, two events took place. First, an informal Christmas Party was held with mulled wine and home-made cookies and Stollen for the students, the tutors and the Max Planck Ph.D. students. Second, the students were invited to a ceremony held in honor of Professor Straus' 65<sup>th</sup> birthday.

### The MIPLC Internship Program

Under the regulations governing the LL.M. program, students must complete a four-week internship in the area of their studies. Although the regulations theoretically permit the internship to be completed before the beginning of the academic year, no member of the LL.M. class of 2004 completed an internship in advance.

The Study and Examination Board established guidelines for the MIPLC internship program. These guidelines set goals for the internship, and fixed a number of requirements with regard to the preparation and the details of the internship and the qualifications and responsibilities of each supervisor and intern. The internship aims to give the student the opportunity to apply substantive knowledge in an actual practical setting, thus deepening the student's expertise. The intern must be integrated actively into the professional life of the host

office. This includes participating in counseling and negotiation activities as well as researching questions of law and preparing expert reports and pleadings. Great importance is attached to the fact that the intern performs the assigned tasks – as far as possible – independently, and generates several pieces of written work, each providing detailed information about his or her level of knowledge. This requires intensive mentoring of the student and regular oral or written feedback on the intern's work.

The placement of the internships for the Academic Year 2003/04 was organized by the MIPLC. Many law firms, companies, courts, government agencies and other organizations specialized on Intellectual Property and Competition Law were interested in hosting MIPLC students as interns and were able to guarantee intensive student mentoring.

#### 4.2 Research Projects & Scientific Conferences

Because the predominant target of last year was the setup and organization of the LL.M. Program, efforts in the fields of research and conferences had to be delayed. However, the first projects have already been drafted and will start in 2004.

#### 4.3 Grants & Fundraising

Since the establishment of the LL.M. Program was the main objective of 2003, fundraising activities were also concentrated on this project.

The MIPLC pursued funds from two major sources: German industry, and the "Bavarian Elite Network" program of the Bavarian Government.

The Max Planck Institute's endeavors to raise funds for scholarships from German industry started to bear fruit when, as mentioned above, Siemens AG and Schering AG agreed to fund a partial scholarship, which helped to prevent one of the students from dropping out of the Program due to financial difficulties.

In the spring of 2003 the Bavarian Government presented the "Bavarian Elite Network", an initiative that aims to create institutions in Bavaria that will provide education at the highest international levels. The Elite Network foresees the establishment of elite study courses, specialized international graduate colleges, an elite network including all institutions and experts involved in the initiative, and the modernization of the existing structure for granting scholarships and the advancement of especially gifted students.

The University of Augsburg submitted, among other programs, the LL.M. IP program of the MIPLC as a project proposal for the Bavarian Elite Network to the Ministry of Science, Research and the Arts. Over 100 proposals were submitted by various Bavarian Universities. A commission of top-class experts selected the LL.M. IP program as one of 29 prioritized projects, of which only some will ultimately receive funding.

## 5. Cooperation with other IP Institutions

In 2003, the MIPLC signed cooperation agreements with both the European Patent Office and the German Federal Patent Court. The agreements call for the parties to pursue opportunities for cooperation on both educational and research projects, including the provision of internships for MIPLC IP LL.M. students.

Further cooperation agreements are in preparation, including, for example, an agreement with the Office for Harmonization in the Internal Market in Alicante, Spain.

## 6. Financial Report

As mentioned in the foreword and reported in detail above, 2003 was not an ordinary year in the life of the MIPLC. This is also reflected in the financial report.

On the expenses side, the main factors of deviation from a “normal” year are, first, that the majority of the staff joined the MIPLC only in the second half of the year, and, second, that the LL.M. course ran only during the last two-and-a-half months of the year.

For these reasons the expenses for personnel, lecturers, travel expenses, and tutors are extraordinarily low in 2003. They will, however, constitute the major part of the expenses from 2004 onwards.

The amount accounted for the rent of the premises in Marstallstraße 8 reflects the circumstance that the MIPLC moved in only in mid March. It should be noted here, however, that the expense for the rent may well go up in the future, depending on the number of students enrolled.

The expenses for public relations activities in 2003 are composed in part of one-time costs for design work (corporate identity, stationery, flyer, poster), and in part of recurrent expenses for advertising and promotion of the LL.M. Program. While the former will be reduced in the coming years (except for the costs for a brochure design, which will fall in the 2004 accounting year), the latter will likely substantially increase as PR activities will be intensified.

Substantial investments were necessary to set up the MIPLC library and the IT facilities. In these fields further investments on a somewhat smaller scale will be necessary in the future, as both the library and the IT equipment will require continuous updates.

The following expenses were paid from the MIPLC budget:

On the income side, application and tuition fees amounting to 108,133.22 € were received. Like the expenses, the income was significantly lower than it will be in the next years, because only the first tuition installment for the academic year 2003/04 was due and paid, while from 2004 on the income will always be composed of the second installment of the previous academic year plus the first installment of the current academic year.

Balancing income and expenses results in a deficit of 178,000 EUR in total or 44,500 EUR per partner. This is less than one half of the maximum annual contribution (i.e. 100,000 EUR) the partners have committed themselves to by signing the cooperation agreement, and it can thus be considered a satisfactory result for the very first year, especially in view of the short time which lay between the MIPLC's foundation and the start of the first LL.M. course.

# Appendix 1: Curriculum – List of Courses Offered in the Academic Year 2003/04

## 1. Introductory Courses

### Legal Research and Writing

Training in the general skills required in scholarship and the conduct of research, with special emphasis on the differences in legal argumentation between common and civil law systems. Topics include: presentation of written work; citation and referencing; conducting a literature search; essay writing; examination writing; doing a dissertation/research project; preparing seminar/conference papers; and preparing work for publication.

### Legal Tradition (Civil Law & Common Law)

Introduction to the structure, historical development, and legal thought of civil law and common law systems; constitutional aspects of the legal system in the U.S., including federal and state legislation and jurisdiction.

## 2. Basic Courses

### European and International (WTO) Law

The legal structure of the EU and the EEA, including the legal constitution and tasks of main EU institutions; impact of principles set out in the EC treaty (such as the subsidiary principle, non discrimination and the “four freedoms,” in particular free movement of goods and services); instruments for harmonization and their legal foundation in the EC treaty. History and background of the WTO treaty; institutions established under the treaty; central principles such as the MFN clause; and legal impacts and ongoing developments.

### European and U.S. Competition Law

Survey of the statutory basis, policy aims, and mechanisms of German, European and U.S. competition (antitrust) law, in particular with regard to the IP/competition law interface; includes a detailed survey of the relevant practice of competent authorities and courts under European and U.S. law.

### European Copyright Law

The theoretical foundation and historical development of copyright in selected EU countries (France/Germany/UK) and differences resulting therefrom (author's right vs. copyright systems, monism and dualism); prerequisites and scope of copyright protection and protection for neighboring rights according to German copyright law, with a comparative view to other EU countries; harmonization of copyright in the EU, including an overview on the existing directives, the state of implementation of the most recent directives, further harmonization projects, and ECJ case law in the field of copyright.

### European Patent Law

The present state and future prospects of the European Patent system, including patentable subject matter, patentability requirements, and scope of protection under the European Patent Convention; patent prosecution before the European

Patent Office; litigation of European patents, including jurisdictional questions; and an introduction to the proposed Community Patent Regulation and other proposed legislation in the patent field.

### European, U.S. and International Design Law

Protection requirements, scope of protection, and enforcement of design rights on the basis of harmonized national law in EU Member States; the Community design system, including the unregistered Community design; comparison of EU law with important divergent features in U.S. and Japanese design law; international design law, including the Hague system for international deposit of industrial designs, and provisions of relevance for design protection in TRIPS.

### European, U.S. and International Trademark Law

Acquisition, scope of protection, and enforcement of trademark rights on the basis of harmonized national law in EU Member States as well as under the Community Trademark system, including a survey of ECJ case law and OHIM practice; comparison of EU law with important features of U.S. and Japanese trademark law; international trademark law, including the Madrid system of international registration; provisions of relevance for trademark law in the Paris Convention and TRIPS.

### International and Comparative Copyright Law

Introduction to special features of U.S. and Japanese copyright law, as well as copyright law in other selected countries or regions; a detailed study of the international Conventions in the field of copyright and neighboring rights; prospects for further international harmonization, including specific matters of jurisdiction and conflict of laws.

### International and Comparative Patent Law

Study of differences between systems for acquiring patents, including patentability requirements, scope of protection and remedies for patent infringement under U.S. and Japanese law; detailed study of the respective international conventions (TRIPS, PCT, etc.); present state of discussion and prospects for further developments on the international level, e.g. in the context of the Doha round.

### Jurisdiction and Conflict of Laws

Principles applied to determine the competence of courts and the applicable law under EU and U.S. law, with a focus on IP conflicts; problems arising in the EU under the Brussels Regulation; the specific relevance of jurisdiction matters and conflict of laws in the digital environment; and harmonization prospects.

### Licensing of IP Rights

The legal context of licensing situations; appropriate terms and conditions in contracts; antitrust and misuse constraints; choice of law; jurisdiction.

**Unfair Competition, Advertising and Marketing Measures I**  
EU directives concerning unfair competition, especially misleading and deceptive marketing measures, including e-commerce and commercial communication; Legal underpinnings and jurisprudence of the ECJ.

**Unfair Competition, Advertising and Marketing Measures II**  
Further analysis of legal problems in the area of unfair competition and trade practices with a comparative view to the United States, including a survey on protection of geographical indications under EU and TRIPS.

### 3. Specialized Courses

#### Arbitration

Arbitration law and strategy, including international conventions controlling recognition and enforcement of arbitration awards; mediation and other forms of ADR, including online dispute resolution in domain name conflicts (UDRP).

#### Computers and the Law

Intellectual property rights in software: comparative analysis of copyright protection for computer programs and patent protection for computer implemented inventions under U.S. and European law, including discussion of public policy issues such as open source code vs. proprietary systems; specific problems in software contracts; acquisition of rights in programs developed in an employer/employee relationship or in larger teams; regulation of e-commerce in the EU.

#### Cross-Border Trade in Intellectual Property

International trade in goods protected by copyright, patent or trademark law has become a matter of enormous economic significance. This course will address a number of the specialized issues raised by such transactions. Consideration will be given to various doctrines that regulate or prevent unauthorized importation of goods protected by intellectual property rights, such as those forbidding parallel importation or regulating trade in so-called “grey goods” and those dealing with the first sale doctrine and exhaustion of intellectual property rights. We will focus as well on the economic and social policy considerations underlying those doctrines. The course will address issues that arise under all three major categories of intellectual property and review the response of the U.S., the EU, and other legal systems to those issues.

#### Entertainment Law

Particular problems related to the rights of performing artists and producers in the entertainment industry, including a comparison between the situation in the U.S. and the EU, inter alia with respect to the relative strength of the parties involved, as reflected e.g. in collective agreements and the role of trade unions, branch organizations etc.; problems of inter-

national contractual law in the entertainment industry; protection of merchandising property.

#### Entrepreneurship

Broad coverage of entrepreneurial issues in privately held companies, focusing on fast-growing high-tech ventures where firm value is highly dependent on intellectual property, with particular attention to start-up financing. The course combines lectures and discussions with expert guest speakers.

#### Industrial Organization and Intellectual Property

This course will focus on the conflict between the protection of Intellectual Property and Competition Policy. This conflict is particularly important for industries at the centre of the emerging knowledge economy. The course will provide an introduction to the economic rationale for both types of policy and clarify how they conflict. The conflict will be illustrated on the basis of recent examples. Possible approaches to reconciling the two kinds of policy will be discussed. In this context the economic analysis of standards, patent pools, licensing and other forms of cooperation between firms will be introduced. This course seeks to introduce participants to a specific area of economics as well as the methods of economic analysis applied there. Economic analysis is becoming increasingly important in the field of competition policy, and this course seeks to provide a foundation for non-economists who will regularly deal with economists and their methods.

#### Innovation Policy

Analysis of the theoretical rationales underlying innovation policies and the institutional implementations of those policies in various nations and supranational organizations, including consideration both of the crucial roles of intellectual property rights systems and of the problems they create. Consideration of intellectual property systems in conjunction with other elements of innovation policies, such as subsidization of R&D, tax incentives for innovation activities, and preferential treatment of particular sources of finance (e.g., private equity, small business loans for innovation projects); quantification of the economic effects of these policies.

#### Intangible Assets Valuation

Consideration of approaches to the valuation of various types of intangible assets, such as patent rights, copyrights and brand names, in the course of licensing negotiations, valuation of start-ups, mergers, acquisitions, and general strategic planning. Emphasis is placed on a detailed understanding of theoretical underpinnings as well as the actual execution of IA valuation tasks. Practitioners from the IP community will be involved to provide hands-on experience in asset valuation.

#### Intellectual Property Project Management

An introduction to appropriate techniques for managing, valuing, selecting and processing intellectual property projects,

based on the premise that intellectual property is in fact created through projects, such as research projects that lead to patents. The course will combine lectures, discussions and case studies.

### **Intellectual Property Prosecution and Enforcement**

Sanctions and enforcement in IP law, with a special view to patent prosecution under German, European and U.S. law; policy and practice considerations in the enforcement of patents and other IP rights; survey of EU legislation on customs control and seizure, as compared to the situation in the U.S., and on pending EU legislation with respect to sanctions for IP infringement.

### **Internet Law I**

Speech on the Internet, including governmental attempts to control or filter speech; intermediary liability for third-party speech; digital rights management and other copyright issues; and domain names as speech; as well as a consideration of the rules and institutions that permit or disallow governance of these issues.

### **Internet Law II**

Electronic commerce issues, including further exploration of copyright and trademark issues (such as framing, linking, and metatags); privacy rights and the database debates; trespass and related theories of property rights; and contracting on the Internet. Consideration will also be given to computer crimes and to governmental attempts to regulate cyberspace like other “places,” such as through zoning and accessibility laws.

### **Managerial Finance**

Introduction to financial management issues in companies, most importantly financial statement analysis, financial planning and corporate control, with special emphasis on management issues of intellectual property companies. The course combines lectures, discussions and case studies.

### **Practical Training in European Patent Law, especially Biotech Patent Law**

Application of the theory of European and international patent law, especially biotech patent law, to practical cases, including discussion and analysis of recent decisions; training on practice cases; patent granting procedure before the EPO; claim drafting practice; and discussion of special problems, such as those deriving from the nature of subject matter to be patented.

### **Practical Training in Media Law**

Practical cases in media law, with a special view to problems occurring in a networked environment. Drafting of contracts, in a national as well as an international context; implications of legal choices in a variety of regulatory frameworks for the production and transmission of protected content; problems resulting from technical protection measures with respect to

access to information; discussion and analysis of recent decisions and legal developments, e.g. with respect to the EU-Infosoc directive.

### **Privacy and Publicity**

Protection of privacy, including protection of private data; personality merchandising under U.S. law with a comparative view to relevant EU legislation as well as national law in selected EU countries, particularly in Germany and in the United Kingdom.

### **Protection of Databases, Plant Varieties and Semi-Conductors**

Comparison of the different regimes of sui generis protection for databases, plant varieties and semiconductors, including EU law, American law, and relevant international conventions. Particular focus on database protection, including the emerging case law in EU countries; problems with respect to competition aspects; and the debate about the appropriateness and feasibility of database protection.

### **Start-up Companies and Intellectual Property**

During this course problems of IP in start-ups will be discussed. Real examples of different complexity will be analyzed. Solutions for licensing as well as cost and valuation problems are presented.

### **Taxation of Intellectual Property**

Domestic and international aspects of intellectual property taxation; tax treatment of royalties and artistic or scientific services; EC developments.

### **Technical Protection of Authors' Rights**

In the age of the digital computer and the internet, authors' rights are increasingly protected by technical measures such as encryption, flags, degradation schemes, watermarking, and so on. In this course, we will study those technologies and the law that protects and regulates them, including the U.S. Digital Millennium Copyright Act, the European Copyright Directive and national implementations of that Directive, the WIPO Copyright Treaty, and the WIPO Performance and Phonograms Treaty. We will also consider the impact of these technologies on traditional limitations on authors' rights such as fair use.
