

## Visa Information for MIPLC Students

Please note that the information provided here is indicative only. The MIPLC is not in a position to provide legally binding advice on visa matters. Such matters may change on short notice. Therefore, please refer to the information provided by the German consulate(s) in your country for current details and information.

Admitted students from most countries outside of the EU must apply for a German national **visa for study purposes** via the German diplomatic representation in their home country. Without this visa, you will not be allowed to enter Germany.

### If You Need a Visa

It cannot be stressed often enough: **Please apply for your visa as soon as possible!**

Visas easily take three to six months or even more to be processed and issued. If the MIPLC program starts in early October, applying for your visa in mid-August is probably too late. We recommend that you commence the visa application process as soon as it is clear that you will definitely join our program. If applicable, this might mean paying your tuition fee several weeks before MIPLC's deadline.

Please read the information provided by the German embassy or consulate in your home country and follow the instructions meticulously. Make sure you submit all required documents with your application, because the embassy will not make any exceptions for you. You will have to follow all the rules, and meet all the deadlines. The MIPLC or the Max Planck Society are unfortunately not in a position to speed up this application process.

You **must not under any circumstances travel to Germany on a tourist visa**. It is not possible to convert a tourist visa and trying to do so will give you a lot of trouble and may lead to expulsion.

Please note: all visa applications usually take several weeks (months, in case of the English test!) to be finalized. In your own interest, please make timely arrangements.

In most cases, you will have to present the following documents:
